A statement of product detail will be maintained with copy provided to customer. Pinnacle Signs will make every reasonable effort to keep the customer informed and to confirm choice of finishes, materials, dimensions, etc.

50% deposit required for orders over \$500 to begin project with balance due upon completion. A 10% late fee will be added to all invoices over 30 days each month until fully paid.

However, based on complexity of the design, quality of client-provided artwork and number of design changes requested by the client additional design charges may be added to the final invoice. Client cancellation of the project after design completion will result in design charges being due and payable.

All signs and related products described above remain the property of Pinnacle Signs until full payment is received.


